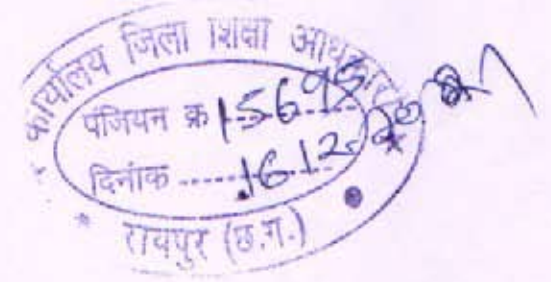

Proposed Enhancement (Academic/ Infra) Programme:-

- Proposed to increase the Grade Pay of the Teaching Staff & encourage them through incentive Programmes.
- Recruitment of additional Expert Mentors in the existing Team of Teachers.
- Upgradation of Computer Lab/Physics Lab/Chemistry Lab.
- Replacement of damaged Computers, Sports, Equipments, Lab Materials, Music Instruments etc.
- Purchase of Library Books, Journals etc as demanded by students & teachers
- Replacing old furniture of the classes with new furniture(Whenever required)
- Proposed construction of new building.
- Proposed Allocation of funds for D.A. & ESIC.

In view of the above proposed development plan & to meet expenses like Grade Increment of Staff and construction of new building etc. The PTA agreed that the School Fee may be increased to a tune of 8% for Academic Session 2022-23. Apart from this, the school faced economic deficit due to Pandemic during session 2020-21 & 2021-22(As Many parents have not paid the School fee. Moreover School has not increased the School fee since last 3 years). The School provided concession in School Fee of 10 to 20% to those Parents who faced economic problem of Corona during Session 2020-21 & 2021-22 also.
